RECORD OF THE DECISION

2014 Admission Arrangements and Associated Policies

- (1) That the proposed increases to the Published Admission Numbers, set out in the document 2014 Community school PANs, be approved.
- (2) That the Admission Arrangements, set out in the following documents, be approved in order that the statutory requirement for admission arrangements to be determined by 15 April will be fulfilled:
 - a) Trafford Primary / Infant / Junior Community and Voluntary Controlled Schools – 2014 Admission Arrangements;
 - b) Trafford Community Secondary Schools – 2014 Admission Arrangements.
- (3) That the introduction of the Sale Central Catchment Area, as set out in the Sale Central Catchment Area (Annexe 2 Document), **NOT** be approved.
- (4) That the Schemes for co-ordinated admissions (Primary and Secondary), as set out in the following documents, be approved:
 - a) 2014 Co-ordinated Admissions Scheme (Primary);
 - b) 2014 Co-ordinated Admissions Scheme (Secondary).

REASONS FOR THE DECISION

The Local Authority, in its role as Admission Authority for community and voluntary controlled schools, is required to determine the admission arrangements for these schools each year by 15th April. The Local Authority is also responsible for the determination of co-ordinated admission schemes; both primary and secondary and for implementation of the Fair Access Protocol.
