The programme is entitled Living Your Best Life with the premise being that people receiving care and support within the scope of the programme; maximise their aspirations and harness their talents through access to more community focused offers and mainstream services rather than defaulting to specialist support. However, where specialist support is required, it is outcome focused, designed around the person, and offers value for money. This engrains the Ordinary Life principle first articulated in the Valuing People white paper in 2001 and further enshrined in the Building the Right Support action plan in 2022 for people with a learning disability

Risks: Insufficient capacity within CLDT (Community Learning Disabilities Team) to assist with capacity assessments and best interest processes if clients need to move out of existing accommodation and/or reduce or increase support when the process of 'Just enough support' has been used. Insufficient resource to support the programme of work. Insufficient appropriate accommodation where there is an identified need to move on, particularly those 18 – 25 or those with a physical disability or behaviour that challenges People /Families objecting to changes required. People being unable to move on from the service, due to a lack of suitable move-on accommodation. Insufficient provider staff to support the work required to reduce staffing support for clients. Recruitment of staff is delayed due to current social care market recruitment issues across the sector. Inability to achieve the savings identified.

(If applicable)	A consultation took place in June 2023 through the Trafford Learning Disability Provider Forum and workshops. The groups included: professionals from across the public and third sector including health, social care, criminal justice, advocacy, carers etc to identify areas that work well and those areas that need improvement.
3	**What barriers, if any, exist to effective consultation with these groups and how will you overcome them?	One key barrier is the fear of change and the potential impact on service users from families. Through the Learning Disability & Autism partnership boards, we aim to develop relationships with families and individuals as they move through the diagnostic pathway, therefore capturing a greater proportion of people diagnosed. Advocates and carers attend the consultations to assist and support with communication needs required. There will be a range of face-to-face meetings at times throughout the day and evening as needed.
