Please support Lancashire Cricket Club's objection to this application by attending the planning committee meeting at 6pm on Thursday 28th March at Trafford Town Hall.

As an urban area, Trafford is already under strain, with heavy traffic on the roads causing pollution, which will only worsen should the development proceed. The traffic generated during construction will exacerbate the heavy flow of vehicles which already dominates the roads directly around the site. The further traffic from new residents will add to this.

Public transport offers an alternative option to travel in and out of the city centre, however routes are already suffering from overcrowding, particularly at peak times. With n additional 433+ residents in the area, congestion will only aet worse. ancashire Cricket Club, which has recently completed a £60m redevelopment, to enhance the facilities on offer for the community.
