Thank you for your email of the 2<sup>nd</sup> March 2022 regarding the Civic Quarter Area Action Plan and any duty to co-operate concerns Manchester may have. We have particularly reviewed the points raised in your email:

- No concerns have been raised by your Council in relation to the 2,500 new homes (minimum) that are expected to be delivered across the Civic Quarter within the plan period;
- This figure (2,500) for the Civic Quarter has emerged as part of Duty to Co-operate discussions that have taken place in the context of the Greater Manchester Spatial Framework and latterly Places for Everyone;
- A requirement for Trafford's housing targets in the Civic Quarter to contribute to needs arising within your Council's area has not been identified; and
- No concerns have been raised by your Council in respect of any of the proposed site allocations within the Civic Quarter (for housing or for other uses).

## Dear Duncan

I write regarding the Civic Quarter Area Action Plan (CQAAP) and in particular in respect of the Duty To Co-operate. As you are aware, Trafford Council has been progressing the CQAAP as a development plan document and has consulted the councils of Manchester and Salford, as well as the Greater Manchester Combined Authority, at the various statutory stages. The CQAAP covers approximately 55 hectares of land within the north-eastern part of the Trafford borough. The CQAAP was submitted to the Secretary of State in November 2021 and Examination hearing sessions are scheduled to commence on 5<sup>th</sup> April 2022.

It is acknowledged, however, that there has been no formal approach, as part of the CQAAP preparation process, in relation to the Duty to Co-operate on cross-boundary matters. However, in accordance with legal advice received, this Council considers that it has fulfilled its requirements when having regard to the following issues:

- No concerns have been raised by your Council in relation to the 2,500 new homes (minimum) that are expected to be delivered across the Civic Quarter within the plan period;
- This figure (2,500) for the Civic Quarter has emerged as part of Duty to Co-operate discussions that have taken place in the context of the Greater Manchester Spatial Framework and latterly Places for Everyone;
- A requirement for Trafford's housing targets in the Civic Quarter to contribute to needs arising within your Council's area has not been identified; and
- No concerns have been raised by your Council in respect of any of the proposed site allocations within the Civic Quarter (for housing or for other uses).

As the Examination process approaches, it would be most helpful to this Council if you could confirm your acceptance with the above matters and confirm that you have no further concerns in respect of the Duty to Co-operate (or on any other matter concerning the CQAAP). This acceptance could be by way of a return email, which would be treated as a Statement of Common Ground at the Examination to assist the appointed Inspector.

Of course, should you have any queries or wish to receive further information regarding the CQAAP, please do not hesitate to make contact. In view of timescales, receipt of your response on the Duty to Co-operate by **Friday 4th March 2022** would be welcomed.
