STATEMENT OF REPRESENTATIONS PROCEDURE

Trafford Council intends to submit a Community Infrastructure Levy (CIL) Draft Charging Schedule for examination, under Section 212 of the Planning Act 2008 (as amended by Section 114 of the Localism Act 2011).

This Statement of Representations Procedure has been produced in accordance with Regulation 16 of the Community Infrastructure Levy Regulations (2010).

Under Regulations 16 and 17, Trafford Council is inviting representations on its CIL Draft Charging Schedule from 13 May 2013 to 24 June 2013.

- That the Draft Charging Schedule has been submitted to the examiner in accordance with Section 212 of the Planning Act 2008
- The publication of the recommendations of the examiner and the reasons for those recommendations
- The approval of the Charging Schedule by the Council
