Examination. Hearing sessions were held
between 28th February 2011 and 10th March
2011, between 25th and 26th May 2011 and
between 28th and 30th September 2011.
Following the hearing sessions in September, the
Council is now consulting upon:

1. A report that summarises the stages of the
sustainability appraisal process for the Core
Strategy with particular reference to the
changes post submission;
2. All suggested additions to the 'living changes
document' CD12.4 made since the hearings
held in May 2011. For the avoidance of doubt,
this refers to all those changes numbered
S300.46 onwards.

The period within which representations may be
made on the documents is between **10th
October 2011 and noon on 24th October 2011**.
During this period, copies of the documentation
will be available for public inspection at all public
libraries/Access Trafford offices in Trafford,
during normal opening hours. Additionally the
documentation will be available on the Council's

CD12.4.
