**Notice of further consultation and reconvened Examination**  
**Hearing Sessions for: The Trafford Council Core Strategy**  
**Development Plan Document (DPD)**

Following the submission of the above mentioned Development Plan Document the Secretary of State appointed Shelagh Bussey, of the Planning Inspectorate, to conduct an independent Examination. Hearing sessions were held between 28<sup>th</sup> February 2011 and 10<sup>th</sup> March 2011, however the hearing sessions were adjourned in order for the Council to carry out further work in relation to:

1. The Regional Centre and Inner Areas boundaries;
2. Policy L5 – Climate Change;
3. The proposed inclusion of the Unitary Development Plan High Amenity Strategic Development Site, at Davenport Green, within the Green Belt.

Additionally the Council has produced a schedule of Suggested Further Changes, to the Publication Core Strategy, (CD 12.4) which is available on its website and upon which you are invited to submit comments.

As part of this consultation process the Inspector has specifically invited (within her Note 5, CD12.67) comments as to how the planning policy changes that were announced in the 2011 Budget might affect your representations and the soundness of the Core Strategy.

The period within which representations may be made on the outcome(s) of this further work is between 18<sup>th</sup> April and noon on 9<sup>th</sup> May 2011. During this period copies of the documentation will be available for public inspection at all public libraries/Access Trafford offices in Trafford and at Trafford Town Hall reception during normal opening hours. Additionally the documentation will be available on the Council's website.
