Written Representation of Salford City Council PRN Number 1043

The Council has considered the representation sent by Salford City Council to Matters 3 and 4 of the Trafford Core Strategy and the Trafford B1 Office PPS4 Assessment (September 2010) and would like to endorse their submission.

The Council is responsible for the majority of the Regional Centre and would be opposed to any development which undermined its primacy for Grade A office development of regional significance. The Council would be concerned about development in Trafford which could adversely affect the role of the Regional Centre, and therefore supports the changes that Salford City Council have suggested to achieve greater clarity over the type and scale of office development, and ensure that it relates clearly to the evidence base. The Council shares Salford's specific concerns over Policy SL4 (Trafford Centre Rectangle), particularly in terms of the potential to result in an over-supply of office floorspace in this location.

If Trafford and Salford City Council wish to discuss this further the Council will be happy to meet and discuss a way forward.
