NOTES FOR GUIDANCE

1. Applications for Notices and Temporary Orders shall only be made on this form
2. Initial enquiries shall be addressed to:

3. A Notice will only be granted on the basis of emergency works or those works of short duration which will be started and completed within the Notice period
4. A minimum period of notice of 7(seven) days (5 working days) is required for the granting of a Five Day Notice (short duration works).
5. An Emergency 21 (twenty-one)-Day Notice will only be granted on the basis of the emergency works satisfying the criteria listed and written supplementary evidence accompanying the form. The Head of Traffic and Transportation reserves the right to refuse the granting of an emergency Notice when he considers that the criteria are not met.
6. A minimum notice period of 6(six) weeks is required for the granting and advertising of a Temporary Order.
7. A form will not be accepted unless the Order No / Expenditure Code field has been completed.
8. The applicant will be responsible for the posting of the notice/order, and consulting with Stakeholders affected by the closure.
