

# BOROUGH OF TRAFFORD (OFF-STREET CAR PARKS) ORDER 2001 (AMENDMENT NO 7) ORDER 2016

WHEREAS the Council of the Borough of Trafford (hereinafter referred to as “the Council”) in exercise of the powers of the said Council under Sections 32 and 35 of the Road Traffic Regulation Act 1984, as amended, and Part IV of the Act of 1984, of all other powers and after consulting the Chief Officer of Police for the County of Greater Manchester in accordance with Part III of Schedule 9 to the said Act of 1984, hereby makes the following Order:-

1. This Order shall come into operation on 1<sup>st</sup> April 2016 and may be cited as the Borough of Trafford (Off-Street Car Parks) Order 2001 (Amendment No 7) Order 2016.
2. This Order removes the car parks specified in Schedule B to this Order from Schedule 3 (Free Car Parks) to the Original Order.
3. This Order amends the Original Order by the addition of the car parks specified in Schedule A to this Order to Schedule 2 (Charged Car Parks) to the Original Order.
4. Save as hereby amended the 2001 Order shall remain in full force and effect.
