## STATEMENT OF REASONS

A number of requests have been received regarding inconsiderate long-stay parking by non-residents. Residents have linked the majority of the parked vehicles to workers in Altrincham town centre and commuters to the nearby Hale train station.

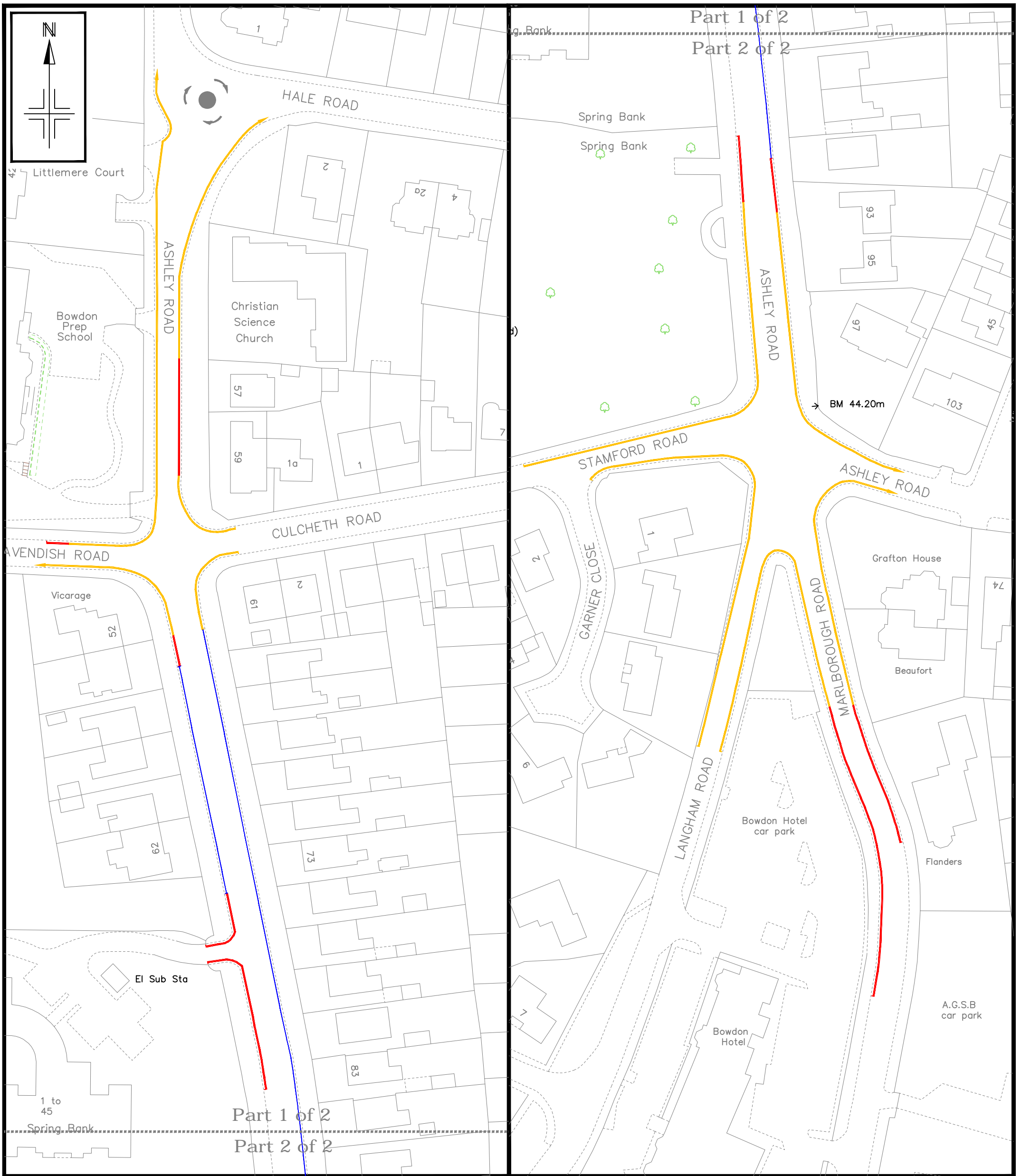
Non-residents regularly park wholly on the footway of Ashley Road (in some cases double parking in parallel) due to the large width its footway. This hinders the movement of pedestrians, particularly disabled persons and pushchair users. Residents have made numerous complaints of being blocked in/out of drives, including difficulties seeing oncoming traffic when egressing.

The footway directly outside a retirement home is regularly used as a space for pavement parking, which obstructs the view of drivers exiting onto Ashley Road thereby causing a road safety risk. Furthermore, this restricts the pedestrians' view when crossing.

On Marlborough Road parking occurs on both sides of the road thereby reducing the traffic movement to a single track. This adversely affects the flow of traffic and is a source of some considerable congestion at peak times during the school pick up/drop off hours. Furthermore, some of the double parking occurs on a bend where visibility is severely limited, this poses a safety risk to pedestrians and motorists alike.

2 informal consultations detailing the proposals were carried out and the results show that a majority of residents acknowledge the parking issues, and are in favour of the introduction of the parking restrictions as illustrated on the attached drawing.

Based on the observations from a number of site visits to the area by Traffic Engineers, the requests received from residents and the 2 informal consultations carried out; It is proposed to introduce 'No Waiting At Any Time' and 'No Waiting, Monday – Friday, 8am – 5pm' restrictions. This is necessary to improve parking conditions and overall road safety on Ashley Road and Marlborough Road.
