

**ROAD TRAFFIC REGULATION ACT 1984****BOROUGH OF TRAFFORD PROHIBITION OF WAITING AND LOADING AND PROVISION OF PARKING) ORDER 2001 (AMENDMENT NO 221)(TEMPORARY) ORDER 2019**

**NOTICE IS HEREBY GIVEN** that, owing to the likelihood of danger and in order provide a disabled persons' parking space and alternative business permit holder parking spaces for the duration of the Brown Street Car Park, Hale redevelopment/construction works, Trafford Borough Council has made an Order the effect of which is to create a disabled persons' parking space and residents permit 'T' holder / business permit 'TT' holder parking spaces as follows:-

**Name of road affected: Ashley Road (North – South arm), Hale**

**Schedule 1a: Proposed - Disabled Badge Holder Parking Only at any time**

Pownall Road, Altrincham	North East	From a point 29 metres southeast of its junction with Lloyd Gardens to a point 45 metres southeast of its junction with Lloyd Gardens
Pownall Road, Altrincham	South West	From a point 28 metres southeast of its junction with Rostherne Street to a point 43 metres southeast of its junction with Rostherne Street
Rostherne Street, Altrincham	North west	From a point 28 metres southwest of its junction with Pownall Road to a point 38 metres southwest of its junction with Pownall Road

Rostherne Street, Altrincham	South East	From its junction with Pownall Road to the cul-de-sac end
