STATEMENT OF REASONS

A number of complaints have been received concerning access issues and road safety caused by vehicles being parked in an obstructive manner on Kenmore Drive and at its junction with Green Lane, Timperley. It is thought that the majority of the parking may be attributed to the nearby Altrincham College of Arts.

The Council is, therefore, proposing to introduce junction protection restrictions in the form of double yellow lines around the junction of Kenmore Drive with Green Lane and on the east side of Green Lane between Thorley Lane and the garden centre entrance, to restrict parking, at all times. It is also proposed to introduce a single yellow line restriction on the north side of Kenmore Drive and on lengths of Green Lane to restrict parking between 9am and 5pm, Monday to Friday.

These restrictions will improve access and visibility for all road users.

These restrictions were initially advertised in March 2020 but the Order was not sealed and the restrictions were not introduced within the legal 2 year timelimit which means that the proposals have to be re-advertised.

PART I - GENERAL

- 1. This Order shall come into operation on 2023 and may be cited as the Borough of Trafford (Prohibition of Waiting and Loading and Provision of Parking Order 2001)(Amendment No 227)(Part B) Order 2023.
- 2. This Order forms an amendment to the provisions of the Borough of Trafford (Prohibition of Waiting and Loading and Provision of Parking) Order 2001, as amended, ("the 2001 Order").
- 3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 4. The expressions, definitions and interpretations specified in Article 4 of the 2001 Order shall apply equally to this Order.

PART II - AMENDMENTS

5. The 2001 Order is hereby amended to include the lengths of roads specified in the Schedule to this Order, with the following provisions denoted by the corresponding codes:-

i)	No Waiting 'at any time'	Code –	7A
ii)	No Waiting Mon to Fri 9am to 5pm	Code -	5E
iií)	School Keep Clear, No Stopping Mon – Fri 8am – 5pm	Code -	SS

- 6. The provisions of Articles 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 16A, 17, 18, 19, 20, 21, 22, 23 and 24 of the 2001 Order, as amended, apply to the lengths of road specified in the Schedule to this Order.
- 7. Save as amended by this Order the provisions of the 2001 Order remain in force.


