



Ward: Urmston 1437 01/23








Hilrose Road/Bradfield Road and Estonfield Drive, Urmston

The Council has been contacted by residents concerned with inconsiderate parking on Hilrose Avenue and around its junction with Bradfield Road obscuring visibility for motorists. The issue is particularly prevalent at school opening and closing times, owing to parked vehicles associated with St Anthony's Roman Catholic School.

The proposal seeks to introduce 'No Waiting At Any Time' restrictions to deter parking issues, to improve pedestrian access and visibility and road safety for all road users.

FIELD ROAD, AoM, SALE

A Residents' Permit 'L' Permit Parking Scheme including Field Road was proposed in 2018, however, it became obvious that, due to the narrow width of the footway the appropriate signage could not be installed. The proposal was changed into a 'Past this Point' scheme but, unfortunately, due to an administrative error, the schedule to the proposal was not revised to reflect those changed restrictions and a Residents' Permit Parking scheme was made operative, however, 'Past this Point' signage was installed. The residents were consulted upon a 'Past this Point' scheme, therefore, it is proposed to amend the traffic regulation Order to agree the signage.

DERBYSHIRE LANE, STRETFORD

The Council has been contacted by a resident concerned with road safety on Derbyshire Lane at its junction with the A56 Chester Road.

Vehicles are parked on both sides of the road and footway, often blocking pedestrian access. The parking also creates a bottleneck and damage is often caused to parked vehicles.

The proposal seeks to introduce a length of 'No Waiting Mon-Sat 8am–6pm' restrictions on the north side of Derbyshire Lane, to deter parking, to improve pedestrian access and visibility and road safety for all road users. The short length of existing 'No Waiting At Any Time and No Loading Mon-Sat 7.30am-9.30am and 4pm-6.30pm' restrictions that are missing from the southwest corner of the junction are to be reinstated.

TIMPERLEY VILLAGE area

The Council has been contacted by residents concerned with parking at the junctions of Thorley Lane/Granville Road, Quarrymans View/Stockport Road and Warburton Way/Stockport Road, Timperley. Furthermore, concerns have been raised about the on-street parking along Thorley Lane between its junction with Granville Road and Stockport Road and the consequent reduction in effective carriageway width, leading to congestion.

The proposal seeks to introduce 'No Waiting At Any Time' restrictions in the form of junction protection at the junctions referred to above, to deter the reported parking issues and to improve pedestrian access and visibility for all road users. Additionally, the proposal seeks to introduce a bus stop clearway and "No Waiting Mon–Sat 8am-6pm" restrictions along Thorley Lane between its junctions with Granville Road and Stockport Road mainly on the eastern side to alleviate the reported parking issues and to improve traffic flow along Thorley Lane.

Trafford Borough Council in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 47, 49 and 53 of the Road Traffic Regulation Act 1984, as amended, (the Act of 1984) and Part IV of Schedule 9 to the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police for Greater Manchester in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

PART I - GENERAL

- 1. This Order shall come into operation on 3rd August 2023 and may be cited as the Borough of Trafford (Prohibition of Waiting and Loading and Provision of Parking Order 2001)(Amendment No 241) Order
- 2. This Order forms an amendment to the provisions of the Borough of Trafford (Prohibition of Waiting and Loading and Provision of Parking) Order 2001, as amended, ("the 2001 Order").
- 3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 4. The expressions, definitions and interpretations specified in Article 4 of the 2001 Order shall apply equally to this Order.

PART II - AMENDMENTS

- 5. The 2001 Order is hereby amended to include the lengths of roads specified in Schedule 1 to this Order, with the following provisions denoted by the corresponding codes:
 - a) No Waiting At Any Time

Code - 7A

No waiting Mon-Sat 8am-6pm

Code -6C

Past This Point Residents' Permit L parking only Mon – Sun 7am – 11pm Code iii) Residents' Permit L Holder Parking Mon – Sun 7am – 11pm iv)

PPL7V

- The lengths of road specified in Schedule 2 to this Order are deleted from the 2001 Order and the 6. provisions of the 2001 Order do not apply to the said lengths of road.
- The provisions of Articles 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 16A, 17, 18, 19, 20, 21, 22, 23 and 7. 24 of the 2001 Order, as amended, apply to the lengths of road specified in Schedule 1 to this Order.
- 8. Save as amended by this Order the provisions of the 2001 Order remain in force.
