## **STATEMENT OF REASONS**

Regent Road Car Park was closed in 2019 to be redeveloped from a surface only public car park into a larger multi-storey pay and display car park, with the site also incorporating residential and commercial properties.

A range of public parking spaces will be available with disabled parking spaces on the ground floor, Electric Vehicle charge points on the first floor and parent and toddler spaces on a number of floors. All specific types of bays will be marked for identification purposes. The car park also includes two lifts for public use.

It is proposed that the car park will incorporate up to 60 contract parking spaces on the upper floors, the lower ground floor and ground floor will include permit parking spaces and business use permit parking spaces, on the lefthand side of the entrance road for businesses within the development. All of which will be clearly signed.

It is proposed to amend the permitted class of vehicle to class A ("Motor cars", "motor cycles," and "invalid carriages" as defined in Section 136(2), (4) and (5) of the Act. In all cases they shall not exceed 1.98 metres in height) from class B (All Class A vehicles without a restriction in height) with a maximum height restriction at the entrance to the car park.

Trafford Borough Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 32 and 35 of the Road Traffic Regulation Act 1984, as amended, and Part IV of the Act of 1984, of all other powers and after consulting the Chief Officer of Police for the County of Greater Manchester in accordance with Part III of Schedule 9 to the said Act of 1984, hereby makes the following Order:-

1. This Order shall come into operation on 1st July 2023 and may be cited as the Borough of Trafford (Off-Street Car Parks) Order 2001 (Amendment No 14) Order 2023.
2. This Order hereby amends the Borough of Trafford (Off-Street Car Parks) Order 2001, as amended (“the 2001 Order”);
3. This Order removes the car park specified in the Schedule to this Order from Schedule 4A to “the 2001 Order”.
4. This Order amends the Original Order by the addition of the car park specified in the Schedule to this Order to Schedule 8 to “the 2001 Order”.
5. Save as hereby amended the 2001 Order shall remain in full force and effect.
