








Bridgewater Road, Altrincham proposed removal of Cg permit bay all surrounding restrictions to remain unchanged






#### STATEMENT OF REASON

A scheme to introduce a disabled persons' permit parking bay on **Thomas Street, Gorse Hill, Stretford** was promoted and received approval in May 2022 but has not yet been introduced on the ground as the resident has requested that its location be revised, as the necessary signage would be visible from his lounge window.

Thomas Street is located within the residents' Match Day Residents' Permit 'B' parking scheme and, as such will require an amendment to the Traffic Order, if a disabled residents' permit parking space is to be introduced at this revised location.

#### STATEMENT OF REASON

A disabled resident of **Beresford Road, Gorse Hill, Stretford**, for whom a C permit parking bay was provided has, sadly, passed away, therefore, it is proposed to remove the bay.

#### STATEMENT OF REASON

A request has also been received on behalf of a disabled resident of **Wilson Street, Gorse Hill, Stretford**, whose son is a blue badge holder, for consideration to be given to the provision of a disabled persons' permit parking bay close to their property.

Members of the Blue Badge Team have confirmed that there is a valid blue badge holder registered at the applicant's address.

Wilson Street is located within a Match Day residents Permit 'B' holder parking scheme and, as such will require an amendment to the Traffic Order, if a disabled residents' permit parking space is to be introduced.

The disabled residents' permit parking spaces in this area are designated 'C' permit holder parking only and are operative on a 24-hour basis.

#### STATEMENT OF REASON

A disabled residents' permit parking bay was provided for a resident of **Mellor Street, Gorse Hill, Stretford** in 2013, however, the man's widow has requested that the bay be removed as he, sadly, passed away in June 2022.

#### STATEMENT OF REASON

A request has been received from a disabled resident of **Urban Road, Altrincham**, who is a blue badge holder, for consideration to be given to the provision of a disabled persons' permit parking space close to the property.

Urban Road is located within the residents' permit Q parking scheme and, as such will require an amendment the Traffic Order, if a disabled residents' permit parking space is to be introduced. However, there are 'At Any Time' waiting restrictions outside this resident's house, therefore, the resident has requested and it has been agreed to propose a disabled persons' permit parking space on the opposite side of Urban Road.

The disabled residents' permit parking spaces in this area are designated 'Cq' permit holder parking only and are operative on a 24-hour basis.

Members of the Blue Badge Team have confirmed that there is a valid blue badge holder registered at each of these applicant's addresses

#### STATEMENT OF REASON

A disabled resident of **Bridgewater Road, Altrincham**, for whom a 'Cg' permit parking bay was introduced, has sadly passed away, therefore, it is proposed to remove the bay.

#### STATEMENT OF REASON

A resident of **Urban Drive**, **Altrincham** for whom a Cq permit parking bay was introduced on Urban Road, is no longer a blue badge holder, therefore, it is proposed to remove the bay.

#### STATEMENT OF REASON

A disabled resident of **Harley Road, Sale**, for whom a 'Cr' permit parking bay was provided, is no longer a blue badge holder, does not own a vehicle and has not got a valid Cr permit, therefore, it is proposed to remove the bay.

#### STATEMENT OF REASON

One of the residents of **Hollins Grove, Sale**, for whom a Cx permit parking bay was provided has, sadly, passed away, therefore it is proposed to reduce the existing 2 vehicle bay to only hold 1 vehicle.

#### STATEMENT OF REASON

A request has been received from a disabled resident of **Bowness Street, Stretford**, who is a blue badge holder, for consideration to be given to the provision of a disabled persons' permit parking bay close to their property.

Members of the Blue Badge Team have confirmed that there is a valid blue badge holder registered at the applicant's address.

Bowness Street is located within an Event Day Past This Point Residents' Permit 'PPF' parking scheme and, as such, will require an amendment to the Traffic Order, if a disabled residents' permit parking space is to be introduced.

The disabled residents' permit parking spaces in this area are designated 'Cppf' permit holder parking only and are operative on a 24-hour basis.
