STATEMENT OF REASONS

A disabled resident of Wardle Close, Stretford, who is a blue badge holder, has complained that the advisory disabled bay that was introduced in 2011 is regularly abused by non-blue badge holders and has requested that consideration to be given to the provision of a disabled persons' permit parking bay to replace the existing advisory disabled bay on Wardle Close, Stretford.

It is considered that the disabled resident of Wardle Close, Stretford would benefit from the introduction of a disabled residents' permit parking bay, that would allow him to park his vehicle, at any time.

Vehicles are regularly parked on the hatched areas of Wardle Close which frequently obstruct the blue badge holder from entering or exiting the advisory disabled bay.

Members of the Blue Badge Team have confirmed that there is a valid blue badge holder registered at the applicant's address.

Wardle Close is located within an Event Day Past This Point Residents' Permit 'PPD' parking scheme and, as such, will require an amendment to the Traffic Order, if a disabled residents' permit parking space is to be introduced.

The disabled residents' permit parking spaces in this area are designated 'Cppd' permit holder parking only and are operative on a 24-hour basis.

Operatives from the OneTrafford waste teams have complained that the parking, which occurs within the hatched areas on Wardle Close, regularly prevents access to the waste bins and also obstructs the free vehicular passage along the Close.

It is considered necessary to remove the hatched areas of carriageway and introduce 'At Any Time' waiting restrictions along those lengths of road.

It is also proposed to introduce 'at any time' restrictions around the perimeter of the central island of Wardle Close to prohibit parking on that side of the road.

STATEMENT OF REASONS

The Council has been contacted by residents concerned with parking on the B5397 Dane Road at its junctions with Willow Court, Leith Road & Arnesby Avenue, Sale. The inconsiderate parking results in obscured visibility for motorists entering / exiting the junctions putting all road users in danger.

The proposal seeks to introduce a 'No Waiting at Any Time' restriction around each junction to deter the reported parking issues, to improve visibility for all road users and to improve vehicular flow.

Trafford Borough Council in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 47, 49 and 53 of the Road Traffic Regulation Act 1984, as amended, (the Act of 1984) and Part IV of Schedule 9 to the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police for Greater Manchester in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

PART I - GENERAL

- 1. This Order shall come into operation on 2021 and may be cited as the Borough of Trafford (Prohibition of Waiting and Loading and Provision of Parking Order 2001)(Amendment No 245) Order 2023.
- 2. This Order forms an amendment to the provisions of the Borough of Trafford (Prohibition of Waiting and Loading and Provision of Parking) Order 2001, as amended, ("the 2001 Order").
- 3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 4. The expressions, definitions and interpretations specified in Article 4 of the 2001 Order shall apply equally to this Order.

PART II - AMENDMENTS

- 5. The 2001 Order is hereby amended to include the lengths of roads specified in Schedule 1 to this Order, with the following provisions denoted by the corresponding codes:
 - i) No Waiting At Any Time Code 7A
 - ii) Disabled Residents' Permit Cppf Holder Parking At Any Time Code RPCppd7A
- 6. The lengths of road specified in Schedule 2 to this Order are deleted from the 2001 Order and the provisions of the 2001 Order do not apply to the said lengths of road.
- 7. The provisions of Articles 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 16A, 17, 18, 19, 20, 21, 22, 23 and 24 of the 2001 Order, as amended, apply to the lengths of road specified in Schedule 1 to this Order.
- 8. Save as amended by this Order the provisions of the 2001 Order remain in force.
