STATEMENT OF REASONS

Following receipt of complaints from local residents, the One Trafford Partnership alongside the Council's Environmental Team have investigated the complaints relating to a vehicle consistently parking on the existing single yellow line on the eastern side of Leys Road between Carlisle Drive and Park Road, Timperley.

As a result of that investigation, it is proposed to add an additional length of restriction into the existing on-street parking consolidation order. It is anticipated that there should be no negative effects as they have been established on the ground, with no queries, for a number of years.

STATEMENT OF REASONS

Works at Cornbrook Park, Old Trafford, consisted of the demolition of existing site buildings and the construction of five residential blocks, with parking available within the development.

The Council granted planning permission under ref number 90991/FUL/17 for the development on the land bound by Bridgewater Way, Chester Road, Virgil Street and Princess Street, Old Trafford, however that planning permission requires works to the highway to prevent further parking issues in the area.

It is considered that the proposed waiting restrictions would help improve access for all vehicles, including emergency services.
