## **STATEMENT OF REASONS**

It is proposed to amend the currently free, time limited parking at Thorley Lane car park. As part of the Fees and Charges review for the Council's 2022/23 budget, which received approval at its February 2022 meeting, however, there were safety restrictions identified and a traffic survey was undertaken with the subsequent additional waiting restrictions being introduced in August 2023.

The proposed charges for Thorley Lane car park would bring the car park in line with numerous car parks across the borough, including Baker St car park in Timperley, where charges were introduced in October 2023. The income received from parking charges is used to off-set all the operating costs, which applies to all car parks, and enables the Council to continue to run these car parks, for public use, and to maintain access to shops and other facilities in the area.
