SERVICES AVAILABLE TO LOOKED AFTER CHILDREN PLACED IN TRAFFORD BY OTHER LOCAL AUTHORITIES

There are a number of looked after children (LAC) placed in Trafford by other local authorities. Trafford Council would like to notify you about the resources and facilities available to looked after children and adopted children who may be placed in Trafford by your local authority. Within this letter we set out the process to notify Trafford Council when a looked after child or young person is placed in Trafford or when their placement arrangements change. We also include information about our Virtual School for Children in Care and the services that we offer to looked after children who reside in the Trafford Area.

Please disseminate this information to relevant professionals within your Children's Social Care Service. We hope that this information will help your professional staff to understand and access the diverse range of services that are available to children and young people residing in Trafford.

It would be useful to receive similar information and contact details about services and opportunities available to any of our looked after children we may have placed in your local authority area.

The attached Notification Form (**see appendix 1**) should be used to inform Trafford Council of any children who are placed in Trafford. The form should also be used to inform Trafford Council of any changes of address or circumstances of the placed child and notify us that the child is leaving the area.

Please ensure that notifications of children placed in Trafford highlight any particular risks or vulnerabilities to assist the professional network within Trafford to respond effectively to any issues that may arise. Where it is relevant to do so we may send and ask you to complete a Sexual Exploitation Risk Assessment form so that we have a detailed understanding of the child's vulnerabilities.

Care Planning Guidance and Case Review Guidance requires the responsible Local Authority to consult with the area authority when they are considering making a

distant placement. If you need to contact Trafford Children's Services to consult with Trafford about a proposed placement of a looked after child in the Trafford area then please contact the Trafford Multi Agency Referral and Assessment Team at the above address.

Education

For Looked after Children moving into Trafford, Social workers are asked to contact Trafford Council as soon as possible to discuss securing a school place. All of our schools, academies and colleges work in partnership and have a collective responsibility to ensure that all young people have access to the best possible learning opportunities so that they can attain good educational outcomes. Each school in Trafford has a Designated Teacher for LAC to promote the educational achievement of LAC who are on the school roll.

Trafford has a Virtual School for looked after children, which supports schools, carers and social workers to ensure that all looked after children engage in their education and attain good educational outcomes.

The Virtual School maintains a register of all LAC and young people aged 3-19 years placed within Trafford including those who are placed here by other local authorities.

The Virtual School Headteacher works collaboratively with all relevant professionals and the Virtual School Team will support schools in Trafford to meet the needs of looked after children placed within Trafford Schools. The Virtual School Head Teacher has specific responsibility for the management of Pupil Premium payments.

The Trafford Virtual School Head teacher is able to offer advice to other Local Authorities who place children in the Trafford area

Access to Trafford CAMHS

The Trafford Child and Adolescent Mental Health Service (CAMHS) is a multidisciplinary service consisting of Psychiatrists, Clinical Psychologists, Nurses, Play and Family therapists, Family support workers, as well as others. The Service is established to assess and treat the mental health difficulties of children and young people where Trafford is their responsible commissioner.

Should LAC living in Trafford have acute mental health needs that require an emergency assessment, this would be provided through the local A&E department. For the assessment and treatment of non-emergency but significant mental health needs, LAC social workers are asked to liaise with the CAMHS team:

Sexual Exploitation and Missing Children

The Sexual Exploitation and Missing Panel (SEAM) forms part of Trafford Safeguarding Children Board's response to CSE. The SEAM Panel meets monthly and focuses on multi-agency responses to victims. Children and young people who go missing frequently are also considered by SEAM. The Panel considers cases at the earliest point of vulnerability; it also gathers intelligence on perpetrators, hotspots, problem premises and young people's networks.

If there are CSE risks (at any level) to children or there is a risk of them going missing, placing Local Authorities must inform Trafford and we will ask you to complete a Sexual Exploitation Risk Assessment form so that we have a detailed understanding of the child's vulnerabilities.

The referral point for CSE and Missing in Trafford is MARAT where there are dedicated Police Officers working with Children's Social Care on this issue. If anyone has any concerns or intelligence that a child is at risk of CSE or Missing then MARAT must be notified.

Independent Missing from Home and Care 72hr interview

In Trafford, the Youth Service has responsibility for carrying out this task. The police share information on a daily basis with Trafford MARAT and this is then assessed for eligibility for a return interview which is conducted by Trafford Youth Service.

Youth Offending Service

Trafford Youth Offending Service is a multi-agency team comprising of staff from Children's Services, Police, Probation and Health. Trafford YOS works with children and young people aged between 10-17 years who are at risk of offending or reoffending. These children/young people are either subject to Statutory Court Orders or Out Of Court Disposals, or work with the Youth Crime Prevention team in a voluntary capacity.
